Tien is CEO of Opus8, an investment and advisory firm which helps technology companies and alternative investment fund managers raise capital. He is also Chairman of Lumious, a leader in corporate tech training and learning analytics, as well as Chairman of Lore Systems, a provider of network engineering, cloud computing, and strategic IT consulting. In 1991, Tien co-founded and served as CEO of CyberRep, Inc. until its acquisition in 2003 by Affiliated Computer Services. CyberRep was one of the largest CRM outsourcing companies in the world with over 2,300 employees and \$80 million in revenue. Today, the CyberRep/ACS business unit is one of the world's largest call center operations, with nearly \$3 billion in revenue as divisions of Xerox, Conduent, and Continuum. Caring Closures International (CCI) expects to transform public health and consumer product safety with a long overdue update to access control technology. CCI's initial product, a locking prescription vial (LPV®), is sold to over 170 customers in multiple pharmacy and healthcare verticals under the Safe Rx® brand, for use in pharmacy dispensing and medication safety, with a **total annual revenue opportunity of approximately \$5B.**

CCI is pursuing insurance reimbursement to pharmacies for LPV dispensing, with five clinical trials underway to validate LPV efficacy and stakeholder economics, which include an approximate 390% ROI to payors and 50% average fill margins for dispensing pharmacies. These economics make this extremely attractive to stakeholders and will incentivize adoption. Initial trial results demonstrate a 100% reduction in missing medication when using LPVs, leading to one state Medicaid commitment for 2023 LPV coverage for MAT medication, and coverage for all controlled substances in 2024.

Safe Rx is the clear category leader in the LPV dispensing market and expects to capture a leading market share in pharmacy dispensing, generated by a 10x manufacturing cost advantage and a 6x workflow cost advantage, all protected by 11 issued and 2 pending patents.

Safe Rx LPVs are expected to have as significant an impact as child-resistant closures in 1970. Universal LPV dispensing of opioids alone would be expected to prevent 7M teenagers from initiating drug abuse and reduce healthcare and other costs by up to \$92 billion over a ten-year period.

CCI is currently offering a convertible note and SAFE (targeting \$3-\$4M) to build readiness for the reimbursement effective date (anticipated Q3 2023). PROPOSED SOLUTION

Datagamz, a patent-pending AI technology inspired by Aristotle's philosophy, enables enterprises to test and optimize digital and human customer experience efforts. It identifies failure points and addresses them through gamification, notifications, insights, and coaching, resulting in exceptional customer experience.

We can acquire practices between 3-5x. We can sell at between 10-13x once we control 4m of EBITDA. This fragmented industry is ripe for a focused consolidation play as larger players have too much capital to look for acquisitions <1m EBITDA. Note that unlike in tech where exits are rare, there were 250 industry exits in 2021.

Potential Return

9-12x assuming 12% growth of 5 practices acquired over 5 years. We may be able to do better. Even if unable to boost the typical 5% growth rate, we can produce a 4-6x exit.

INTRO

We are a roll-up acquiring mental health practices. The industry is experiencing immense demand post-pandemic and is quite recession-proof as insurance pays for most visits. Despite failing to do many business 101 things, founders are able to grow practices to the \$2-4 million revenue mark with relative ease.

PROBLEM OPPORTUNITY

Practice founders leave tons of money on the table as they do not negotiate contracted rates with insurance companies and have major accounts receivable issues. They also lead chaotic cultures with no merit-based hiring, employee engagement surveys, client result measurement or employee performance reviews.

SOLUTIONS

- We will re-negotiate insurance rates upwards, introduce higher margin lines of business like TMS, and fix administrative issues that lead to big accounts receivable.
- We will build cultures where clinicians and patients thrive. This means employee engagement surveys and performance reviews, client result tracking, and more.

TRACTION

Since raising our seed round at the end of 2022, we recruited one of the nation's leading experts in the business, negotiated an LOI for 4x, built a 4-practice pipeline, and a diligence team.

THE TEAM

Our 5-person team has two 8-figure exits in this industry. We have a clinical psychologist who built the largest practice by revenue in Massachusetts. We have an ex-navy carrier officer who grew a practice from 600k top-line to over 7m. We have an attorney who did due diligence and contract drafting for Shark Tank deals.

SOCIAL IMPACT AND VALUES

We are a for-profit with social impact. Our values are polarizing in our industry and thus quickly attract values-aligned sellers and repel values-misaligned sellers. We stand for:

1. Ending burnout culture. Treating people kindly produces better business outcomes.
2. Abundance over scarcity. Underpricing is worse for clinician and patient.
3. Mental health is more than talk therapy. We encourage innovation like TMS and psychedelics.

Value Proposition: Maxwell Biosciences is a biomimetic anti-infectives drug discovery platform company that is pioneering world-first “**One drug for MANY bugs**” innovations to address humanity’s most serious, unmet infectious disease threats. As a pre-clinical stage company, Maxwell’s technology is backed by over \$40M in government grants, angel investment and VC funding. With **scientific validation in over 250 peer-reviewed published studies and very encouraging FDA feedback already received**, Maxwell’s novel and patented compounds have been shown by multiple independent labs to safely & rapidly inactivate a broad-spectrum of infectious pathogens, including key virus families, bacteria and fungi - including many drug resistant strains - and biofilm formations. Maxwell is creating a library of drug candidates that will provide solutions for both human & animal livestock applications - with an **annual \$165 Billion in market potential for antibiotics, antivirals and antifungals including \$121B in humans and \$44B in livestock** - while tackling the growing global threat of antibiotic pollution and drug-resistant diseases.

Senior Leadership Team (SLT): The SLT has a deep bench of experience in life sciences drug discovery & development, operations and high-return exits. The CEO has 20+ years of CEO experience and the COO is the former US Head of R&D at Shire Pharmaceuticals who successfully commercialized over 80 drug products, including several multibillion blockbusters like Adderall XR, Carbatrol & Claritin.

Challenge: #1: The current drug development process is limited by a ‘One drug for one bug’ paradigm, thus, it does not effectively address evolving & emerging pathogens (e.g. new variants), nor does it address the unmet need posed by conditions where combinations of multiple pathogens or biofilms are present, such as Chronic Rhinosinusitis (CRS). **#2:** Our environment is now contaminated with antibiotics. Rising levels of drug-resistant diseases are projected to result in over 10 million deaths globally a year by 2050.

Solution: Maxwell’s First-in-Class CLAROMER® biomimetic platform technology creates synthetic compounds that mimic the only cathelicidin antimicrobial peptide of the human innate immune system (LL-37). Maxwell’s CLAROMERS have demonstrated a broad-spectrum of pathogen membrane disruption - including confirmed pan-coronavirus and pan-influenza efficacy - and effectiveness against all tested bacterial and fungal pathogens cultured from Chronic Rhinosinusitis, indicating “One drug for MANY bugs” efficacy. The CLAROMERS have also shown the ability to prevent the development of drug resistance which is becoming an increasing problem with antibiotics.

IP / Technology: Maxwell has a strong & growing patent portfolio with broad composition of matter patents that are owned outright with plenty of time to commercialize the platform and compounds. Ongoing R&D efforts are supported with the world’s foremost scientists and drug development experts - who are members of our core team, Scientific Advisory Board and Clinical Advisory Board - in the fields of biomimetic chemistry, immunology, nanotechnology, peptide synthesis, bioengineering and otorhinolaryngology (ENT disease indications).

Market: Maxwell’s CLAROMERS are poised to disrupt the Infectious Disease market estimated at \$165 Billion annually, growing to over \$200B in 5 years - with \$121B associated with viral, bacterial and fungal infectious disease indications in human populations and \$44B associated with animal populations. Initial entry will tackle our strategic lead indication of Chronic Rhinosinusitis (CRS) which affects 7M+ patients annually in the USA with a \$40+ Billion annual market. Our lead drug candidate for Chronic Rhinosinusitis will be offered in a nasal spray device and is anticipated to enter Phase 1 clinical trials starting in 2024.

Revenue Model: Maxwell’s platform business model is designed to generate revenues through strategic deals for both human and livestock markets through spinouts, partnerships & licensing deals with large Pharma companies & government bodies - with both upfront & ongoing payments. For human commercial sales, we will start with pharma industry partnerships for production and distribution until we can scale our own operations. For animal commercial sales, we will license the technology to animal pharmaceutical companies to mature and take to market. We will partner with governments to stockpile against future pandemics, service military personnel (e.g. wound care anti-infectives), and address other infectious disease concerns (e.g. Ebola, gonorrhea).

According to cdc.gov, 2023, there are currently 133 million people with diabetes and pre-diabetes in the US alone. Treatment costs are approaching 1 trillion USD and are projected to grow by 20% by 2030 and by 46% by 2045.

Technologies / Special Know-How

We have three patents pending blood glucose estimation technology which uses special LEDs with AI based methodology for interpreting data that is implemented within a wearable device. To reduce development risk, cost, and time, MedWatch Technologies has executed a license, exclusive for glucose applications, to a new sensor platform with associated health monitoring software. The platform is fully operational. We expect to obtain FDA clearance for glucose estimation in approximately eighteen months.

Problem

Living with diabetes requires measuring glucose levels many times a day. The standard of care has been piercing the skin and measuring it with a glucose meter (glucometer). This is painful, inconvenient, potentially debilitating, and expensive which leads to poor compliance and significant health consequences.

Competition / Current Solutions

Glucometers require piercing the skin to obtain a blood sample. There are two leading wearable invasive Continuous Glucose Monitors on the market- Dexcom and the FreeStyle Libre from Abbott Labs. The Dexcom and Libre use a needle to insert a tiny sensor wire into the skin to measure interstitial glucose levels every 5 minutes. Patches must be replaced every 10 – 14 days, and these patches cost hundreds of dollars per month.

Our Solution

MedWatch Technologies will lead a new market category of *non-invasive* CGMs with a sensor that simply sits on the skin and non-invasively measures glucose concentration. Every few minutes, MedWatch will report glucose concentration on its cloud-based multi-sensor platform. The patient and doctor can see a continuous correlation between behavior, eating, sleeping, and glucose readings. This platform will support other MedWatch sensors and monitoring applications to provide patients, their medical providers, family, and friends with actionable health data that is comfortable, pain-free, convenient, and affordable.

NAI has established a strong relationship with BGI Worldwide Logistics to handle its international freight forwarding requirements. NAI's two third-party logistics providers (3PL) operates almost 100 warehouses nationwide. NAI's supply chain and distribution are managed through EDI/API connection to its NetSuite ERP system. The Company invested over \$300,000 in addition to significant management time in its ERP and EDI system solutions to support the Company's anticipated rapid growth.

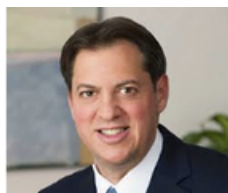
