He serves on the boards of The Washington Institute for Business, Government & Society; Frederick Innovative Technology Center, Inc. (FITCI); Junior Achievement; Association for Enterprise Growth; and Austin Venture Association. He was appointed by Governor Martin O'Malley to the Maryland Venture Fund Authority which manages \$84 million in venture capital.

ARC Medical is significantly improving surgical patient recovery by preventing internal adhesions, the most common surgical complication. We developed a liquid adhesion barrier device that works by providing a physical barrier between tissues that mechanically separates the tissues to prevent surgical adhesions. A surgeon needs less than 250 mL of the liquid, which is applied to the intraperitoneal cavity during an abdominal or pelvic laparoscopy or open laparotomy surgery. The liquid flows throughout the entire abdominopelvic cavity and forms a protective barrier film on all tissues throughout the cavity that prevents surgical adhesions from forming. We are dedicated to making products that ensure safety for patients during and after their surgery.

Aquillius Ventures is a women-owned, minority-owned, firm that supports entrepreneurs that are commercializing cutting-edge technologies to improve the health of people and the health of the planet.
